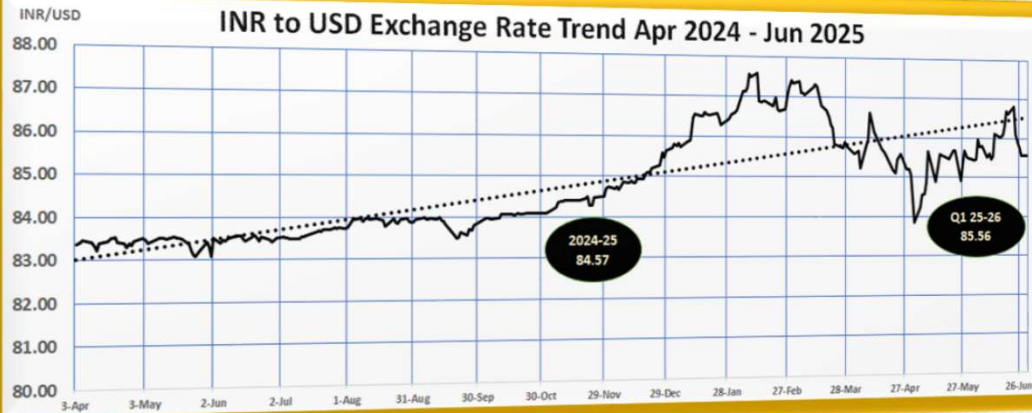

India's GDP growth rate

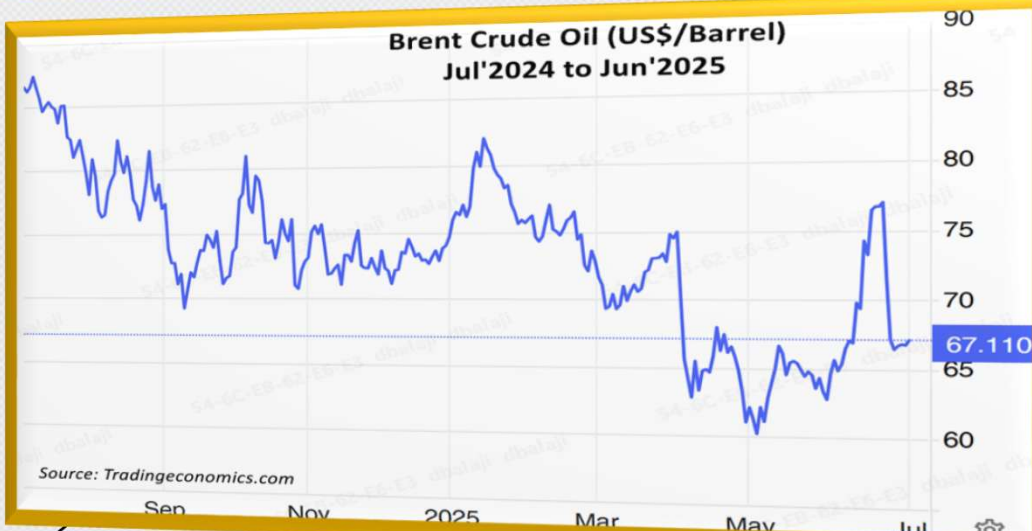
Real GDP growth, annual percent change

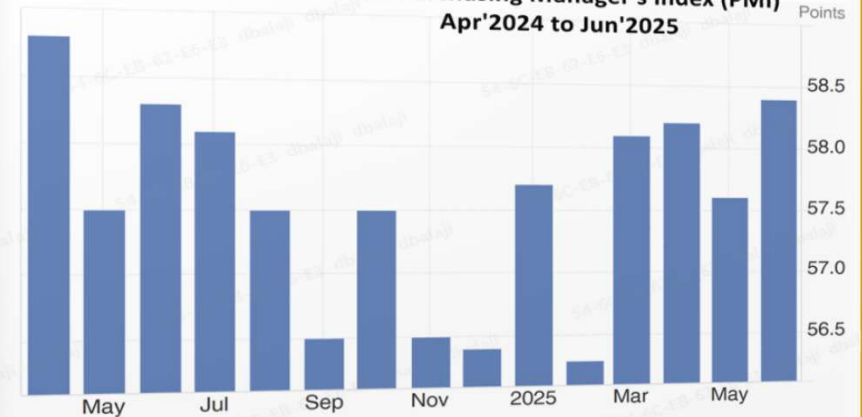

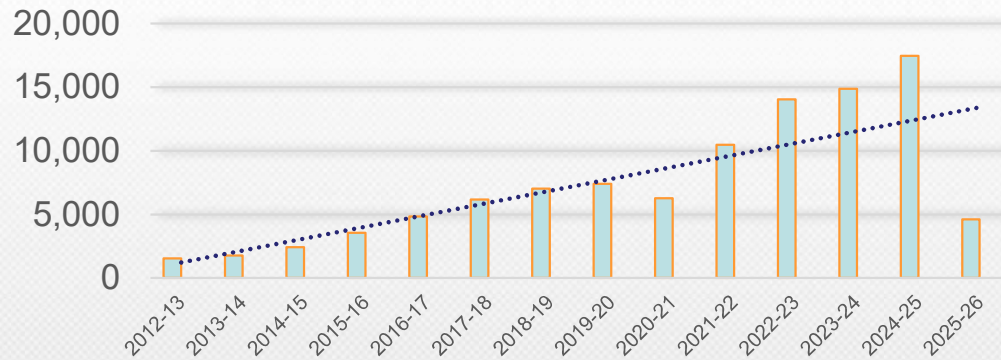

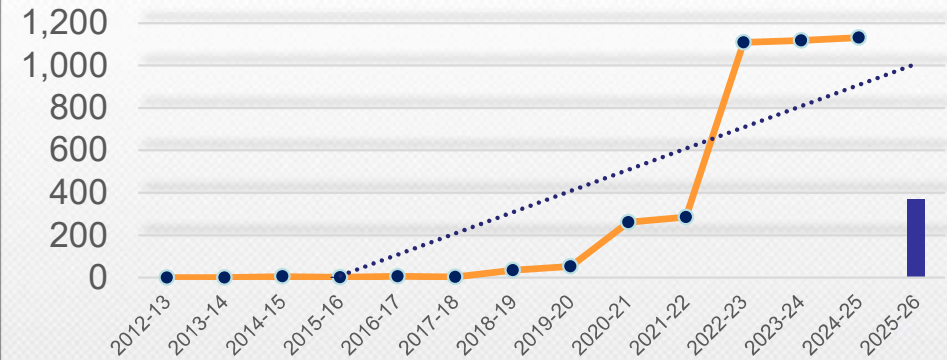

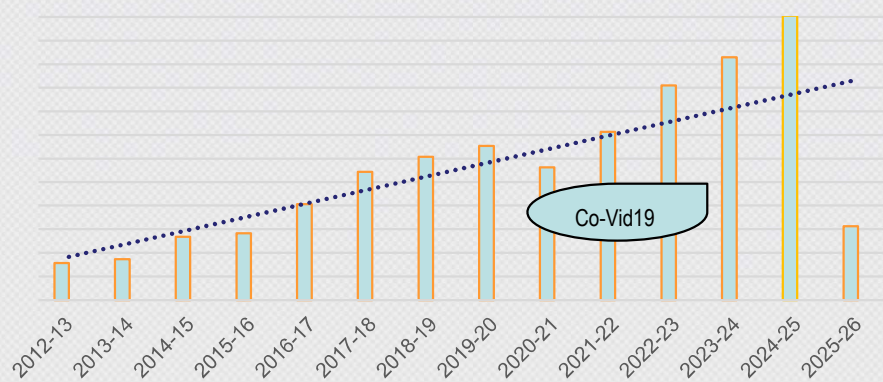
Revenue (Rs.Millions)



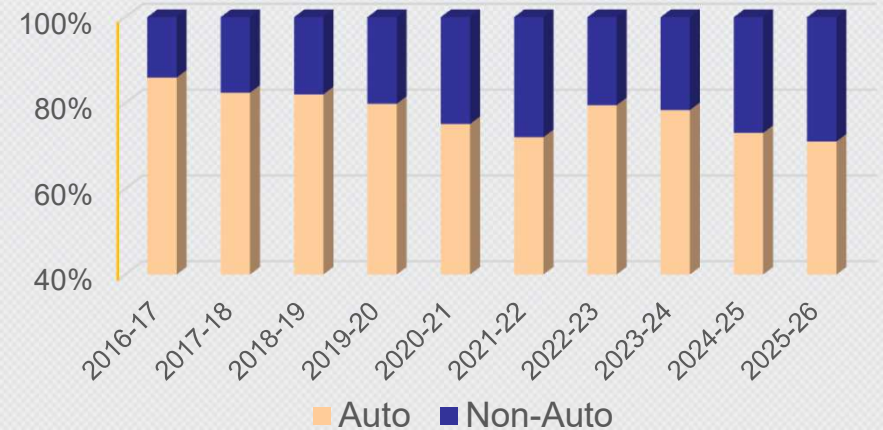
Export (Rs.Millions)



Sales Volume



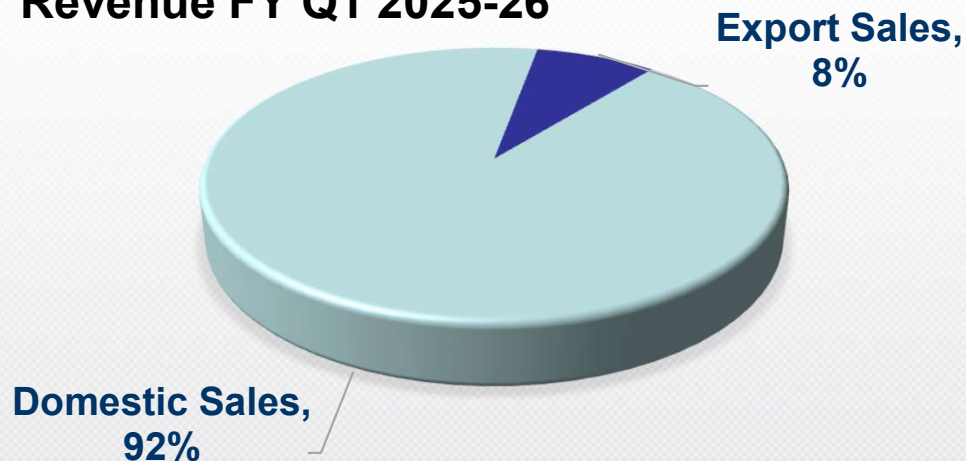
Share of Auto Vs Non-Auto Businesses



1D | Sales Performance Comparison Q1 FY 2025-26 vs Q1 FY 2024-25

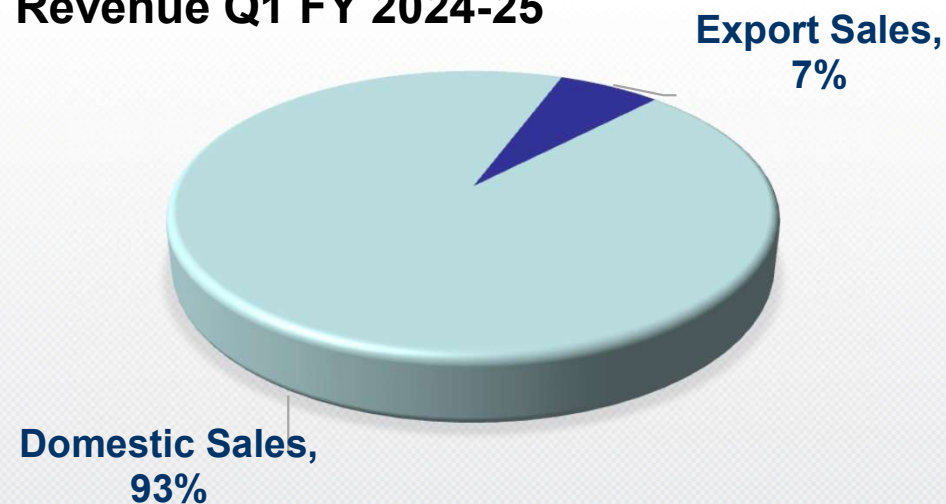

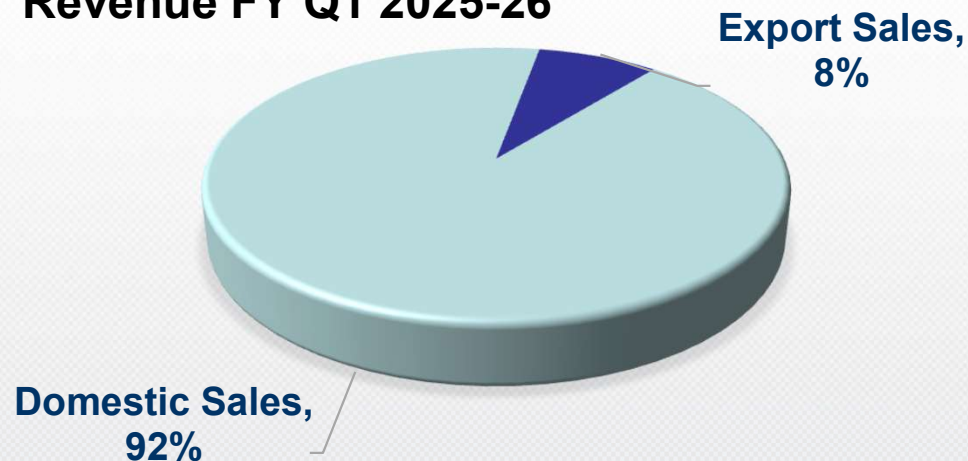

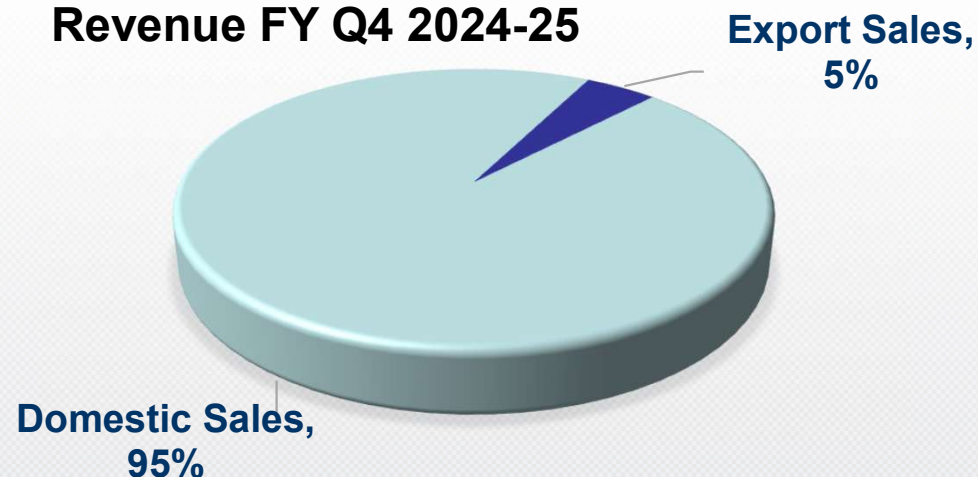
1E | Quarterly Sales Performance Comparison Q1 FY 2025-26 vs Q4 FY 2024-25
